Child Care Fee Subsidy – 2017 Summer Care



Families are required to demonstrate a continuous need for child care services to maintain eligibility for a child care fee subsidy. A stop in child care service at any time throughout the year, including the summer months, may result in ineligibility as the need for continuous child care may no longer be demonstrated by the parent. The information below is for both families who receive help with child care costs (fee subsidy) and child care service providers to prepare and plan for child care needs in the summer. Families are required to update and receive confirmation from the City of Ottawa of any changes in their subsidized child care services.
